



## Does your facility have unused & unneeded medications?

*Consider donating them to RoundtableRx!*

### What is RoundtableRx?

RoundtableRx is Minnesota's Medication Repository Program. We accept donations of safe, quality, unexpired medications and medical supplies. These donated products are then redistributed to Minnesotans in need.

### Why donate medications to RoundtableRx?

Our medications and medical supplies are delivered to Minnesotans who are otherwise unable to afford them. Additionally, donating medications and supplies to RoundtableRx will reduce the volume of pharmaceutical waste your facility destroys and can save you money!

### What is acceptable to donate?

- Prescription-only and over-the-counter medications and supplements
- New, unopened medications in original manufacturer packaging (pills, inhalers, etc.)
- Medications bubble packed by a licensed pharmacy (pills must have identifying markings)
- Products with expiration dates of 6 months or greater
- New, unopened medical supplies (insulin pumps, testing supplies, etc.)



### What cannot be donated?

- Opened, used or compromised medications and supplies
- Medications in amber vials
- Bubble packs with more than one medication per bubble or card
- Expired medications, or medications that expire in less than 6 months
- Medications requiring refrigeration or storage outside of room temperature
- Controlled substances (opioids, benzodiazepines, etc.)
- Medications requiring a REMS program for dispensing
- Select specialty medications (request clarification from RoundtableRx)

## Who can donate to RoundtableRx?

RoundtableRx can accept donations from skilled nursing facilities licensed under chapter 144A, and assisted living facilities licensed under chapter 144G. RoundtableRx can also accept donations from individuals.

## What if a facility does not qualify?

If your facility does not qualify to donate directly to RoundtableRx, consider recommending us to your clients and their families. If a client and/or their family has unneeded medications, recommend they donate it to RoundtableRx! ## How much does it cost?

Nothing! There is no cost associated with donating to RoundtableRx. Even shipping is free!

## Who handles the logistics of donating?

Donation logistics are handled by RoundtableRx and our partners at SIRUM. We will provide your facility with education on the donation process, send pre-paid shipping labels, and furnish shipping supplies.

## How does a facility sign-up to donate?
