RoundtableRx is a volunteer-run licensed wholesale pharmacy with the Minnesota Board of Pharmacy. The organization functions as the sole state-created medical repository. The repository is run by licensed pharmacists, pharmacy interns, and other skilled volunteers. The medication program receives prescription medication surplus from long-term care facility residents, inspects the medication, inventories the medication, and distributes to individuals struggling to afford their medication. The program reduces the amount of disposed of medication resulting in a positive impact on the environment. The program started the second half of 2020, building its infrastructure, developing its business operations, governance and finances. It received its first gift of medication in December 2020.

However, the organization's governance function is fully functional with an active and engaged board of directors and officers, along with a significant increase in internal staff, and during the 2021 compliance review, it was discovered that the 2020 Form 990 was not timely filed.
